Local 1010 Proposed By-Laws Change ARTICLE V

Finances

Section 5.d. Payment of Bills.

The following five (5) full-time officers: President, Financial Secretary, Chairperson of the Grievance Committee, Vice-Chairperson of the Grievance Committee, and Secretary of the Grievance Committee shall receive daily salary based on Labor Grade (4) as indicated in current Agreement between ArcelorMittal Steel and the United Steelworkers and daily per diem and average Plant Incentive Margin per week as calculated on September 1st of each year. The seniority provisions of the Collective Bargaining Agreement shall be used to determine the length of vacation to which any full-time officer is entitled while serving with the Union. **Change to read:**

The following four (4) full-time officers: President, Financial Secretary, Chairperson of the Grievance Committee, and Vice-Chairperson of the Grievance Committee shall receive daily salary based on Labor Grade (4) as indicated in current Agreement between ArcelorMittal Steel and the United Steelworkers and daily per diem and average Plant Incentive Margin per week as calculated on September 1st of each year. The seniority provisions of the Basic Labor Agreement shall be used to determine the length of vacation to which any full-time officer is entitled while serving with the Union.
